Mohawk Valley Center for the Arts cordially invites all artists – painters, photographers, sculptors, etchers, lithographers, fiber artists, potters, and fine-arts-makers using other forms, to submit work. This year’s exhibition theme is: “Portals”.

“Portals” can be represented psychologically or physically, literally or figuratively. It’s your interpretation on the theme. Can be in any medium. Can be 3-dimensional. Must be original.

ENTRY DAYS: JULY 5-8, NOON – 3:00PM

Please deliver your art work with the **Artist Submission Form** to MVCA, 401 Canal Place, Little Falls.

ENTRY FEE

There is a non-refundable entry fee of \$20 for one entry and \$35 for two entries. An artist may enter no more than two pieces. Fees are used for awards, judging, printing, postage and advertising.

ELIGIBILITY

All regional artists are invited to participate. Art work must not be over 3 years old and must never have been shown at MVCA. All work must be original to the artist, suitable for display and, if 2-dimensional, well framed and ready for hanging with screw eyes and wires securely attached.

SPECIFICATIONS

2-D sizes are not to exceed 42” wide including the frame. Diptychs and triptychs must fall within these guidelines. Sculptures are not to exceed 24” wide X 24” long X 24” high.

NOTIFICATION

Artists will be notified by MVCA only if their work is NOT selected by the juror for the exhibit.

GENERAL TERMS AND CONDITIONS

Selections for the exhibit and the award winners will be decided by the juror. No accepted works may be withdrawn by the artist before the close of the show. Any artist who removes work prior to the closing of the show will not be permitted entry for any future MVCA Regional Art Event. A 30% commission will be taken on sales during the exhibition. Selected works will be on exhibition in the 401 Gallery–July 15th – August 13, during regular gallery hours, Wednesday – Saturday, Noon – 4pm
